

# How to Connect to RISS

RISS members may connect to RISSNET™ in two ways:

## (1) Node Connectivity

A node refers to connectivity of an agency-controlled information technology system to RISSNET. States that access RISS as a node will have a high-speed connection into RISSNET to obtain access to RISS resources. States with an interest in obtaining a connection as a node will need to complete an application to RISS.

## (2) Individual User Connectivity

Individual users access RISSNET via an Internet Service Provider.

A RISSNET enrollment package must be obtained from your regional RISS center.
